PERAK CHINESE CHAMBER OF COMMERCE AND INDUSTRY Rules and Regulations of PCCCI Youth Committee

1. 名称：

- 1.1 霹靂中華總商會青商團

2. 简称：

- 2.1 青商團

3. 宗旨：

- 3.1 吸引年轻一代加入, 并加强壮大本会的组织, 以及培育成为本会的接班人, 以更有效的实现商会的既定目标。
- 3.2 培育及提升华裔青年男女成为知识创业, 智慧经商的新动力, 为社会经济的转型与提升制造更有利的条件。

4. 活动范围：

- 4.1 举办有关人际关系、法律知识、交流会、工商管理知识、经验分享、生涯规划、就业辅导、政府对青年和女性创业之援助与贷款计划等讲座或课程, 参观政府部门、重点工厂或公司等等。
- 4.2 举办团员各别的专长发表会, 以及互相交流学习的活动。
- 4.3 本团协助本会主办的活动。
- 4.4 一切活动不可违反本会章程条文。

5. 年龄限制：

- 5.1 凡年龄在 18 至 45 岁之间的大马男女辈属青年。(除在藉学生)

6. 团员资格：

- 6.1 凡申请成为本团团员者, 须填妥申请书交到本会秘书处, 以提呈中央理事会讨论及批准方得成为本团团员。
- 6.2 若本团团员违反本团的规则, 中央理事会拥有绝对权力终止其团员资格。
- 6.3 本团只接受华裔男女青年以个人身份加入。

7. 活动基金：

- 7.1 本团可接受公众人士之捐款，由本会签发收条。
- 7.2 本团有权使用有关活动基金于本团所推动的活动。
- 7.3 有关活动基金交由本会总财政保管。
- 7.4 开设霹雳中华总商会青商团银行户口。
- 7.5 团长，秘书，财政联名签署单据，提交本会总秘书及总财政批准。

8. 委员会：

- 8.1 顾问：不限年龄, 开放予会员及非会员。
- 8.2 团长：一位 (由中央理事会成员担任及不限年龄)。
- 8.3 副团长：两位 (一位由中央理事会成员担任及不限年龄; 另外一位则由本团委员会成员遴选)。
- 8.4 秘书：一位 (本会秘书处职员或由本团委员会成员中遴选)。
- 8.5 副秘书长：一位 (由本团委员会成员中遴选)。
- 8.6 财政：一位 (由本团委员会成员中遴选)。
- 8.7 委员：7位。

(注：以上委员会各单位须经过中央理事会通过)

9. 委员会任期：

- 9.1 本团委员会的职位任期将与中央理事会的期限相同。

10. 冻结活动：

- 10.1 若本团活动违反本会宗旨, 中央理事会只要以三分之二的多数票通过, 就有绝对权力冻结本团之一切活动。

11. 修改：

- 11.1 在必要时, 本团可修改团规, 必须经中央理事会通过方为有效。

1. Name:

1.1 Perak Chinese Chamber of Commerce and Industry Youth Committee

2. Name In Brief:

2.1 PCCCI Youth Committee

3. Objectives:

3.1 To encourage participation of youth in strengthening the organization and grooming successors for PCCCI to achieve specific aims.

3.2 To groom youth with entrepreneurial knowledge as business driving force, repositioning social economy for a better condition.

4. Terms of Reference:

4.1 To conduct public relations, legal knowledge, interaction meeting, business management knowledge, sharing of experience, life planning, employment counselling, seminars or courses on incentives & business loans provided by the government, visiting government departments and priority factory or company.

4.2 To hold forums for members talking about their expertise as a learning platform.

4.3 PCCCI Youth Committee shall assist in all activities organized by PCCCI.

4.4 All activities organized by the PCCCI Youth Committee shall not violate the Articles or Regulations of the Constitution of PCCCI.

5. Age Limit:

5.1 Any Malaysian youth who has attained the age of 18 to 45.
(Exclusive of student)

6. Membership Qualifications:

6.1 Any application for membership shall be submitted to PCCCI Secretariat for the approval of Central Committee.

6.2 If a member violates the rules & regulations of the PCCCI Youth Committee, the Central Committee should have the absolute power to terminate his membership.

6.3 Either Chinese male or female youth individual member shall be accepted for membership.

7. Activity Fund:

- 7.1 PCCCI Youth Committee may accept donations from the general public, receipts shall be issued by PCCCI.
- 7.2 PCCCI Youth Committee shall have the power to use the fund to promote activities.
- 7.3 The Treasurer of PCCCI shall be in charge of the Fund.
- 7.4 Perak Chinese Chamber of Commerce and Industry shall open a current account under the name of “ PCCCI Youth Committee.”
- 7.5 The Chairman, Secretary and Treasurer of PCCCI Youth Committee are to sign all bills before submitting to the Secretary-General and Treasurer of PCCCI for approval.

8. Committee:

- 8.1 Advisors : No age limit, open to member & non-member of PCCCI.
- 8.2 One Chairman : A member from the Central Committee without age limit.
- 8.3 Two Vice- Chairmen: A member from the Central Committee and a member shall be from the Committee.
- 8.4 One Secretary : PCCCI Secretariat staff or a member shall be chosen from the Committee.
- 8.5 One Assistant Secretary: A member shall be chosen from the Committee.
- 8.6 One Treasurer: A member shall be chosen from the Committee.
- 8.7 Seven Members

(Remarks: The above list shall be passed by the Central Committee.)

9. Tenure of Committee Members:

- 9.1 The tenure of Committee Members shall be coincided with the term of Central Committee Members.

10. Activity Freeze:

- 10.1 If the activity contravenes the objectives of PCCCI, the Central Committee shall freeze all activities with 2/3 votes at the meeting.

11. Amendment:

- 11.1 The committee shall amend the rules and regulations if deemed necessary. Any amendments shall be passed by the Central Committee.
