Our Guest of Honour was YB Nga Kor Ming, Deputy Speaker of Parliament and Member of Parliament of Teluk Intan. Invited guests include Tan Sri Datuk Ter Leong Yap, Tan Sri William Cheng, Dato' Lim Kok Cheong and YB Dato' Ngeh Koo Ham. Almost 1,000 guests attended this dinner together with our PCCCI Central Committee and Youth Committee members. We wish to express our sincere thanks to all our donors and supporters for making this anniversary dinner a success.





Speech by Dato' Liew Sew Yee, President of PCCCI



On behalf of the Central Committee of PCCCI and its Youth Committee, let me welcome and express my deep appreciation to your presence here to celebrate the 111th Anniversary of PCCCI. My special thanks also go to Yang Berhormat Tuan Nga Kor Ming, the honorable Deputy Speaker in Parliament.

In the past 111 years, Central Committee members of PCCCI together with the support of its members, we are able to uphold our duties and responsibilities, and timelessly developing the Chamber's affairs according to its constitution and objectives.

In areas of safeguarding the interest of our members in commerce, industry, agriculture and other economic sectors, we organize regular sessions of talks, seminars and briefings on topics related to trade, investment, training to update our members to ensure that they are in line with the current development of the business environment.

We spare no effort to promote and response to the state government and its agencies to ensure the expansion of the state economic cake as well as unity among its people.

We also work closely with our National Chamber, ACCCIM, and its other 16 affiliated chambers throughout Malaysia as well as the NGO and universities to participate in the events such as economic conferences, trade missions, trade exhibitions and any other activities that help to boost the cooperation between us.

In July last year, we celebrated PCCCI 110th Anniversary with a series of events. The highlight of the events is the anniversary dinner, attended by top government officials, diplomatic missions as well as representatives from affiliated chambers of ACCCIM and many other trade organizations from China and other countries. We recorded a hefty 2,500 guests for the evening.

Other than the main event as mentioned, we organized a cycling event called "Tour De Perak" with 24 cyclists taking three days cycling 450km, visiting 5 branches and 2 affiliated Chambers in Perak. By doing charity in each stop, we also built a strong bonding with these branches and affiliated chambers.

The "Jungle Trail Race" climbing 10 km up the Kledang Hill in Menglembu was attended by 1,000 participants from all walks of life, brought PCCCI closer to the community in Ipoh at large. As a joint project sponsored by Perak State Government, we put up the Ipoh Cultural Parade 2017 with 2,296 participants taking part in the parade. We were awarded the Malaysia Book of Records for having the largest number of participants in the cultural parade.

PCCCI held its AGM last June to elect its new committee for the 59th term. We are very please that not only the election process went through smoothly (actually, without contest) but was able to bring in a new and younger team in the management including a first female holding the Assistant Secretary General position.

Being encouraged by the change in government after the 9th May, and following the new government steps toward changes in style and way of governing the country, we, in Central committee, decided to make changes in the formation of the various working committees. With emphasis that the role is to address the issues faced by its sectors' members and make proposal to state government with a view that our problems are taken into consideration and act upon.



In response to the call by the government to support the Tabung Harapan Malaysia, our Honorary Life President Dato Lim Kok Cheong and his Yee Lee Group came forward in donating a sum of RM 1 million. Our calls to our members for contributions received a sounding response and a total sum of RM2.7 million was collected and a mock cheque was presented to YAB Menteri Besar of Perak.

PCCCI initiated a meeting with Perak Malay Chamber of Commerce, Perak Indian Chamber of Commerce, Federation of Malaysian Manufacturers (FMM) Perak Branch, Malaysia International Chamber of Commerce and Industry Perak Branch, to draw up a joint memorandum of understanding (MOU) to our YB Menteri Besar of Perak. In the joint MOU, we address the followings:

**Natural Gas Distribution System should cover the city of Ipoh where F & B outlets are on the rise,
Electric Train Service (ETS) should increase its frequency of trips between KL and Ipoh as well as reducing its travelling time, Congestion at the North South Highway and the need to expand from 2 lanes to 3 lanes, Ipoh Airport connectivity to neighboring countries is overdue, Enhancing the efficiency of public service delivery system, Foreign workers issues, Effective dialogue between government and business community, Improving the utilization of existing industrial parks, Urging the state government to seek for higher development budget allocation from the federal government. We are jointly going to present a copy of the MOU to the State Exco, YB Dato Seri Mohammad Nizar Bin Jamaluddin, Committee chairman for investment and Corridor Development, as part of tonight program.**

2018 has been a very significant year to Malaysia. For the first time in 61 years, a new government under Pakatan Harapan took over the government administration without undesired disturbances and uncalled for disruption. The peaceful transition of the government is now a role model that has been admired the world over. On top of that, we now also have a world's most elderly Prime Minister Tun Dr Mahathir.

Tun Dr Mahathir has been instrumental in the bid for successful taking over of the government. We believe and pray that the Harapan Government will implement policies and strategies that keep the stability in the country especially in areas of potential racial and religious conflicts.

PCCCI, being a significant force among the NGO in Perak, has a social responsibility toward maintaining social stability, racial harmony and robust economic development in the state. On education and cultural fronts, we believe in equal treatment by providing a fair and balance approach for all races. Only through these efforts, a truly Malaysian Malaysia will be in the making.

With the rising of China as the world second largest economy, coupled with President Trump of USA slamming an escalating trade war against China, conflict of this kind will certainly impact not only the two largest economies but also the rest of the world. Being located in the centre among Asean countries and being in a strategic point in the China proposed Belt and Road Initiatives, Malaysia has great opportunities to take advantage of the Industry Revolution 4.0. We should encourage investors to look into developing full automation in the production and processing by making use of the natural resources available in abundance in this country.

We also urge the government to develop a comprehensive plan in term of identifying local and foreign investors to fully develop an industry that comply to achieving Industry Revolution 4.0, covering AI, Big Data, IoT, machine automation including the development of human resources in its related field.

Factory automation and services automation has given rise to the opportunity to reduce the employment of foreign workforce. In this new era, we see manual workers will be replaced by automation processes. By transforming manual workers to handle automation, we created a set of skill workforce that control machines that can work 24 hours, 7 days a week.

By reducing the dependence of foreign workers, local workers must develop skills to handle automation, giving rise to blue collar workforce that can earn much higher wages. Full automation not only allow a worker's productivity to increase due to higher output from machine and also assurance of quality. This leads to cutting down of working hours from 5 days week to 4 days week. In return, income per worker increase, working hours reduce, giving rise to people having more time for leisure and leisure industry will boom in the coming era.



A week ago, PCCCI initiated a dialogue with 30 representatives of shop owners and tenants along Jalan Theatre and Jalan Mustapha Al-Bakri in the vicinity of Octagon Complex, together with YB Wong Kah Woh, Member of Parliament for Ipoh Timur, YB Jenny Choy, State Assemblyman for Canning Garden and a team of 8 MBI councilors.

The dialogue concluded that an Octagon Cultural Street Task Force was set up to look into transforming the shops along the two streets into a cultural and tourism related business streets so that Octagon Cultural Street will be another tourist attraction in Ipoh. We hope the state government and MBI will provide incentives in terms of exemption in taxes or levies to the shop owners to assist them during this transformation process.

PCCCI believes that promoting local culture helps to enhance economy as a form of commercial activities. At the same time, PCCCI involvement in education, especially in Chinese schools is wide and influencing. Our Central Committee members and members are very involved in the school board of governors. Because we understand that education is the key to success of our younger generation.

Therefore, we would like to call upon the government to treat schools of all streams equally by providing fair allocation of fund to allow our schools to perform its role in building a bright future of the next generation.

Finally, I would like to reiterate that in this multi-racial, multi-cultural and multi-religious country, it is imperative for today's government to answer to the call of the people in giving equal and fair treatment in areas of politics, economy, cultural and education.

With that note, I would like to thank you all for being with us.
